PRESENTER PROFILE



Rebecca McCauley, Ph.D., CCC-SLP, is a professor in the Department of Speech and Hearing Science at OSU. She is also an ASHA Fellow, Board-recognized specialist in Child Language and an associate editor of the American Journal of Speech Language Pathology. Since 2001, Dr. McCauley has authored or edited 5 books dealing with a variety of children's communication disorders, including language disorders, stuttering, and ASD. Her most recent book, "Treatment of Language Disorders in Children" (2nd edition) is co-edited with Marc Fey and Ronald Gillam and will be available in early 2016. She is co-author (with Edythe Strand) of the Dynamic Evaluation of Motor Speech Skill, a test useful for differential diagnosis of children with severe speech sound disorders, including CAS, and has begun work with Brazilian colleagues to develop an analogous test for Brazilian Portuguese.

COURSE ABSTRACT

This presentation will focus on evidence-based practices related to differential diagnosis, assessment for treatment planning, and interventions for severe speech sound disorders (SSSDs) in children, with a primary focus on severe phonological disorders and childhood apraxia of speech (CAS). A comprehensive approach based on the ICF-CY (WHO, 2007) is taken in this session because although speech production problems are central to children with SSSDs, they frequently co-occur with equally significant and sometimes more or increasingly significant problems in overall communication, language and literacy. Therefore, developing strategies for addressing these various challenges as part of a comprehensive approach is key to successful management. Numerous case-oriented exercises will be used to help participants immediately practice working with the concepts being presented.

LEARNING OBJECTIVES

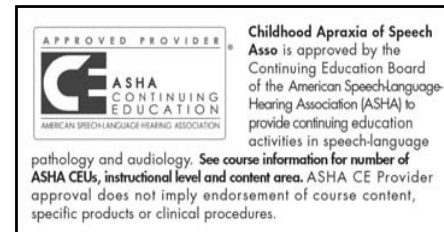
At the end of this presentation, participants will be able to:

1. List characteristics consistent with severe SSDs, including CAS, that can help with differential diagnosis.
2. Describe motor learning principles to use in effective intervention planning for both CAS and other severe SSDs.
3. Summarize recent research developments for interventions specific to CAS.
4. Create comprehensive treatment plans for children with severe SSDs across problem areas (communication, oral/written language, speech).

COURSE LEVEL

Intermediate/Professional Area. Participants are expected to have some prior academic and/or clinical experience with children with severe speech disorders. Families are most welcome at the workshop with the understanding that the level of presentation will be at the intermediate professional level.
